GENERAL INFORMATION

WCDSB has embarked on an exciting and innovative initiative that offers an extra-curricular team with esports opportunities for our grades 6-12 students. Designed to build collaborative skills and team engagement, esports is a type of competition that uses video games. Most commonly, esports are organized, multiplayer video game competitions, often involving professional players and teams.

RATING CATEGORIES

The Entertainment Software Rating Board (ESRB) is a non-profit, self-regulatory body that assigns ratings for video games and apps so parents can make informed choices.



Everyone

Content is generally suitable for all ages. May contain minimal cartoon, fantasy or mild violence and/or infrequent use of mild language.



Everyone 10+

Content is generally suitable for ages 10 and up. May contain more cartoon, fantasy or mild violence, mild language and/or minimal suggestive themes.



Teen

Content is generally suitable for ages 13 and up. May contain violence, suggestive themes, crude humour, minimal blood, simulated gambling and/or infrequent use of strong language.

*Regardless of age, no WCDSB student will have access to esports games at school that carries a rating above TEEN, and students that are under the age of 13 will only have access to games that are rated EVERYONE or EVERYONE 10+.\

SAFETY RECOMMENDATIONS

In the interest of safety, we strongly recommend:

- 1. Regular stretching/walk breaks between games.
- 2. Students bring emergency medications (e.g., asthma inhalers, epinephrine auto injector) to all esports activities.
- 3. Students regularly drink fluids to stay hydrated.

ELEMENTS OF RISK

Although the risk of immediate injury in esports is minimal in nature, there are certain potential long-term injuries to be aware of. The most common types of injuries are Repetitive Strain Injuries (RSI) which typically occur in the wrist of PC gamers, or hands of console gamers. Users experiencing discomfort while engaging in esports, e.g., back injuries, headaches, blurry vision, or other pain (including addictive tendencies) are encouraged to bring this to the attention of their coaches or teachers. Additionally, gamers may be exposed to misbehaviour of other gamers, which may also carry a risk. Any student who believes they are at risk should notify a teacher or coach.
